General Information

Selection Criteria

Successful applicants will demonstrate:

- Maturity, good character, and scholastic aptitude
- A commitment to cultural immersion in a host culture through a home-stay experience
- · An ability to meet cross-cultural challenges with maturity, humor, and an open mind
- Concrete ideas for sharing their overseas experience in their U.S. home school/community upon return

NOTE: Preference will be given to applicants who have received their high school education in the U.S. and who have not resided or studied abroad.

Basic Eligibility Requirements

Eligibility details for the 2021-2022 program include:

- You must be a U.S. citizen.
- You must be born between December 26, 2002, and June 26, 2006.
- You must be enrolled in high school (which includes home school) at the time of application.
- The YES Abroad program seeks applicants of all racial, ethnic, religious, and socio-economic backgrounds; sexual orientations; and welcomes applicants with disabilities.
- Applicants of all grade-point averages and academic performance are encouraged to apply.
- For additional eligibility information, please see "Additional Eligibility Information" in the application.

Application Process and Timeline

• Tuesday 08 Dec 2020 5:00 PM U.S. Eastern Time - Application Deadline

The written application includes the following sections: Cover Photo, Biographical Information, Placement Profile, Country Preferences, Essay Questions, Letter to Host Family, Academic Information, Parent Statement, Educator Recommendation, Photos, Statistical Information, Health Information, Passport Details (note: a passport is not required to apply), and Legal Information. Submitted written applications will be evaluated by a Scholarship Review Committee, and applicant contact details will be shared with regional Interview Coordinators, who will contact applicants regarding their regional interview.

• December 2020 - Application Evaluation

A Scholarship Review committee comprised of YES Abroad implementing organization staff, experienced volunteers, and program alumni evaluate applications, specifically the essays, host family letter, teacher recommendation, parent statement, and high school and extracurricular information.

• December 2020 - February 2021 - Regional Interviews

A regional Interview Coordinator will contact each applicant on a rolling basis during this period to share details of the interview schedule. All applicants must be interviewed and interviews may occur in December, January, or February. It is very important that you respond in a timely manner to your Interview Coordinator's communications. Arrangements can be made for candidates unable to interview in-person.

Late January 2021 - Submission of Completed Medical Evaluation and Academic Credit Agreement Forms

Applicants must submit complete Medical Evaluation and Academic Credit Agreement Forms in order to remain eligible. Visits with your health care professional and dentist are required to complete the Medical Evaluation Forms. If additional health information is requested, follow-up visits may be necessary prior to international departure. A signature from a school administrator is required to complete the Academic Credit Agreement Form. Note: Medical information will not be considered as part of selection.

• March 2021 - Finalist and Country Assignment Announcement

Applicants and their parents/guardians will be notified by email of their application status in March on a rolling basis. Finalists will be notified of their country assignment, as well as their next steps and follow-up responsibilities. Some applicants may be notified of Alternate status. Alternates might be awarded a Finalist position, should a Finalist be unable to participate in the program. More details regarding Alternate status are provided upon notification.

• March 2021 - Submission of Finalist/Alternate Acceptance Form

To remain eligible, Finalists and Alternates must complete and submit the Finalist or Alternate Acceptance Form and other required documents to indicate that they intend to participate in the program or accept Alternate status.

• June 26-29, 2021 - National Pre-Departure Orientation

All participants must attend the National Pre-Departure Orientation (National PDO) from June 26 to 29, 2021. Attendance is required for the duration of this event, which serves as a primary training tool for participants. The program provides participants with travel (from the 50 U.S. states and Washington, D.C.), lodging, and meals at the event venue, as coordinated by the implementing organization.

• Late June - mid-September 2021 - Anticipated International Departures

International departures occur on a rolling basis, anticipated to begin as early as immediately following the conclusion of the National PDO in late June, and continuing through mid-September of 2021. All participants must travel between the U.S. and their host country on the same flight itinerary, as assigned by their implementing organization.

• May - July 2022 - Anticipated International Returns

International returns typically occur in May and June, but may occur in July. Most participants must attend a two to four day orientation at the U.S. point of international return. All participants must travel between the U.S. and their host country on the same flight itinerary, as assigned by their implementing organization.

Additional Information

Beginning in approximately March, Finalists must take additional steps in order to remain eligible for the program, including and not limited to receiving a visa, joining preparatory activities, completing independent readings, and additional verification of health information.

Academic Credit

Applicants for the program will be asked to agree to the following stipulations concerning academic credit:

- YES Abroad participants are not guaranteed to receive academic credit for specific courses taken overseas.
- The decision to accept overseas coursework as fulfilling the academic requirements of a U.S. school rests solely with the U.S. school and is the applicant's responsibility to arrange prior to program

departure.

- Schools overseas may impose academic standards or other requirements in determining grade-level
 placement that differ from those imposed in the school that the applicant currently attends. The
 availability of courses provided in-country during the program may or may not meet the specific
 academic requirements of a U.S. school and these courses are determined by the host school incountry.
- The program strongly advises against participants completing online courses and extensive
 independent study while overseas. The program must give prior approval and will request that a
 participant limit the time spent on such work during the program, should the program determine that
 it interferes with the participant's ability to fully commit to and participate in the normally required
 host school curriculum and other activities, host family, and host community. Disciplinary action may
 be taken in some cases.

Miscellaneous

- Participants who have just completed their 11th or 12th grades of high school and those who'll be
 over 18 years of age at the start of the program are advised that participants in these demographics
 will generally be placed in classrooms with students one to two years/grades younger.
- All applicants are expected to thoroughly review the scholarship website, including the FAQ page, for important scholarship details, such as information about visas and common costs not covered by the scholarship.

Additional Eligibility Information

The U.S. Department of State's Bureau of Educational and Cultural Affairs (ECA) offers many opportunities for American youth to participate in international exchanges. ECA seeks to represent the diversity of America in these youth exchange programs and to make sure the selection process is fair and transparent.

Strong selection preference is given to those who have not previously participated in one of the exchange programs listed below or lived abroad for six months or more during the past five years.

This eligibility policy applies to the following programs, which take place outside the United States:

- Kennedy-Lugar Youth Exchange and Study (YES Abroad)
- National Security Language Initiative for Youth (NSLI-Y)
- Congress-Bundestag Youth Exchange (CBYX)
- Youth Leadership Program (participants who traveled overseas only)
- Youth Ambassadors Program

Current or Previous Participant in ECA Exchanges

U.S. citizens who are current or past participants in any of the above mentioned programs are not eligible to participate if:

- The two programs take place in the same calendar year.
- The individual is currently participating, or has already participated, in an academic year program.
- Current or past participants in a short-duration program of eight (8) weeks or less are not eligible for another short-duration program but are eligible for an academic year program. The restrictions above apply only to in-person programs taking place outside the United States. Participation in a virtual program does not make the applicant ineligible for programs of any length. An individual may not participate in more than two of the above-listed programs, unless one of the programs was completely virtual..

Family Members of Department Employees


For a period ending one year following the termination of such employment, association, or service:

- Employees of the U.S. Department of State/U.S. Agency for International Development are ineligible. This provision includes all employees, paid or unpaid (including part-time or temporary employees, consultants, externs, interns, fellows and personal services contractors).
- Immediate family members (e.g., dependent children) of employees of the U.S. Department of State/U.S. Agency for International Development are ineligible. This provision includes all employees, paid or unpaid (including part-time or temporary employees, consultants, externs, interns, fellows and personal services contractors). Self-supporting children who live apart from their parents are qualified to participate.
- Employees (and their immediate family members) of private and public agencies under contract or grant with the U.S. Department of State who perform services on behalf of U.S. Department of State exchange programs are ineligible.

How to Apply

- Online Application Form: Complete and submit the application form online. All applications and recommendation forms must be submitted online, except in rare cases in which the applicant can demonstrate that this requirement presents a significant impediment to applying for a YES Abroad scholarship. Applicants who need to make alternative arrangements for submission of their application must do so by November 15, 2020. - Terms and Conditions: Carefully read the Terms and Conditions. This form must be signed by the applicant and all parents or legal guardians. Upload the completed signature page of the Terms and Conditions Form to your application. Applicants who do not want to upload the signature page may mail the final signature page to YES Abroad. The form must be postmarked by the application deadline.
- Official Grade Transcripts: Request an official copy of your grade transcript from your high school
 and upload a PDF to the application portal by the application due date of Tuesday 08 Dec 2020 5:00
 PM U.S. Eastern Time. Transcripts must include completed courses, grades, and GPA.
- **Teacher Recommendation:** Have **one (1)** teacher submit a recommendation using the online form. The recommendation must be submitted by the application due date of Tuesday 08 Dec 2020 5:00 PM U.S. Eastern Time.
- Parent/Guardian Statement: Have one (1) parent/legal guardian submit a statement online supporting your application. The statement must be submitted by the application due date of Tuesday 08 Dec 2020 5:00 PM U.S. Eastern Time.

While YES Abroad is an invaluable experience and a time of tremendous growth for participants, it is important for candidates and their families to understand that by its nature, the program can be emotionally and physically demanding. Being immersed in a different culture, placed in an unfamiliar host family, school, and community often involves emotional stress during an adaptation period that varies from person to person.

If a candidate is currently experiencing medical, emotional, psychological, or family difficulties, or has recently recovered from such issues, the demands of a study abroad program can severely exacerbate such difficulties or be cause for relapse. For this reason, the program requests as much information as possible be given below regarding your health status. Your responses to these questions will **not be considered** during the selection process. Collecting this preliminary medical information helps facilitate program placement should you be selected as a finalist for the program. More information on the medical review process can be found in the YES Abroad Terms and Conditions, which all applicants and their parent(s)/legal guardian(s) must thoroughly review and sign.

To be considered for program selection, you will be required to have a physician complete the official YES Medical Evaluation form and return it to YES Abroad. This form will be made available following the program application deadline. Failure to submit this form by the stated deadline may result in cancellation of your application.



Your letter will be read as part of your application and may be shared with your host family if you are selected. Consider formatting your response like an actual letter with a salutation and closing.
